William son of Mabilie to all his people and to French and the English both present and future greetings Know that I gave Helte de Billi for his service and homage of my land and my rent in my town of Nutelee ("White Notley, Essex) namely Pinkeland for 20 acres and in Posseberbe 13 acres and the land which Humfrid held of me for 12 acres in Chaldewell[] and 12 acres in Halvehyde[] and the land which Godwin del Broc held for 8 acres of me and an acre and a half of meadow belonging to the aforesaid 8 acres and my meadow of Langeford[] for which Roger de Langef [ord] he gave me 16 d[] and the land of Osbert de Tornham and his service and the miller's seat which my brother Gilbert son of Mabilie made and 8 d[] rent which Terri the baker held of me in the town of Reilee. Let Helte hold the aforesaid lands and rent freely, quietly and honorably, himself and his heirs, from me and my heirs in fee and inheritance for two solids, paying yearly for all service, namely, 12 d[] at Easter and 12 d[] at the feast of St. Michael. If it should happen that I and my heirs could not warrant to the aforesaid Helte and his heirs the aforesaid lands, or that I and my heirs in my manor of Nutelee should be returned to him and his heirs, to these witnesses, Robert, the son of Nigel, Martin, his son, John, the son of Ernald, Hugh, his brother, Adam, the son of Godfred
